The product handed in for evaluation by the company mentioned above is used for disinfecting surfaces in companies which are preparing and processing foodstuffs.

Information on the formulation as well as concerning the conditions of application formed the basis of this evaluation.

Furthermore, a determination of the migration of substances of the disinfectant onto surfaces which have been treated with the product was performed.

The results of the migration analysis were summed up in the

Test report no. 5841/1-I of the company ISEGA Forschungs- und Untersuchungsgesellschaft Aschaffenburg of 4 April 2011.

The compliance of surfaces treated under employment of the disinfectant with

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union No. L 338/4 of 13.11.2004, modified by app. no. 5.17 of the regulation (EC) no. 596/2009 of 18 June 2009, Official Journal of the European Union no. L 188 of 18 July 2009, article 3,

as well as with

Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuch (Lebensmittel- und Futtermittelgesetzbuch - LFGB) in der Fassung der Bekanntmachung vom 24. Juli 2009 (BGBl. I S. 2205), zuletzt geändert durch Artikel 1 der Verordnung vom 03. August 2009 (BGBl. I S. 2630), §§ 30 und 31,

(Foodstuffs, Consumer Goods and Animal Feed Code (Foodstuffs and Animal Feed Code - LFGB) in the version of the notification of 24 Juli 2009 (BGBl. I p. 2205), last amendment by article 1 of the law of 3 August 2009 (BGBl. I p. 2630), §§ 30 and 31),

is not restricted. However, the analysis of moist and fatty foodstuffs for possible residual contents of the disinfectant on a random basis is recommended.

Thus, the disinfectant Virus Guard DL may be used as intended for disinfecting surfaces in companies which are preparing and processing foodstuffs.

This expert's opinion consists of 2 pages. It was subsequently modified on 20 April 2011.
